

## **University Canada West**



#### **Application process:**

- 1. Book Tamwood Pathway Program.
- Apply through the process described here <a href="https://www.ucanwest.ca/admissions/apply/partner-referral-application">https://www.ucanwest.ca/admissions/apply/partner-referral-application</a> and pay the non-refundable application fee. Apply for a scholarship at the time of application, if required.
- Receive the Letter of Offer and pay the deposit.
   There will be instructions about submitting official documents on the Letter of Offer.
- 4. Complete Tamwood Pathway Program and meet the English requirements. Tamwood will send a proof of English directly to UCW.
- 5. Receive the Letter of Acceptance and apply for a Study Permit.

#### **Academic Pathways from Tamwood Careers**

- 1. Complete Tamwood Career program.
- 2. Apply for admission and submit a completed Request for Transfer Credit at the same time. Find more information here https://www.ucanwest.ca/admissions/transfer-credits.
- 3. Receive the Letter of Offer and pay the deposit. Wait about three (3) weeks.
- 4. Get Letter of Acceptance and apply for a Study Permit extension.

#### **Application deadlines:**

<u>Admissions</u> will close once the enrolment capacity of each program is reached. It is recommended to apply at least three (3) months in advance.

<u>Scholarships:</u> check deadlines for each bursary/award/scholarship on the website.
